## 4. FIRST AID MEASURES

### 4.1 Description of first aid measures

#### Eye contact

Where Diphoterine is not available, rinse eyes with copious amounts of water for at least 20 minutes. Protect uninjured eye.

#### Skin contact

Where Diphoterine is not available, wash immediately with plenty of water and soap. Remove contaminated clothing immediately.

Immediately seek medical attention.

#### Inhalation

Remove person to fresh air and keep comfortable for breathing. Call a poison centre or physician if you feel unwell. If breathing is irregular or stopped, administer artificial respiration.

#### Ingestion

If accidentally swallowed rinse the mouth with plenty of water (only if the person is conscious) and obtain immediate medical attention. Do not induce vomiting.

### 7.1 Precautions for safe handling

#### Safe handling

Wear appropriate personal protective equipment. Use only under a chemical fume hood. Keep away from heat/sparks/open flame/hot surfaces. Take measures to prevent the build-up of electrostatic charge. Ensure adequate exhaust ventilation, especially if dust, aerosol or fumes will be generated. Avoid contact with skin, eyes and clothing. For precautions see section 2.2.
