## 4. FIRST AID MEASURES

### 4.1 Description of first aid measures

#### Eye contact

Where Diphoterine is not available, rinse eyes with copious amounts of water for at least 20 minutes. Protect uninjured eye.

Remove contact lenses if present and easy to do. Continue rinsing and seek immediate medical attention.

#### Skin contact

Where Diphoterine is not available, wash immediately with plenty of water and soap. Remove contaminated clothing immediately.

Immediately seek medical attention.

#### Inhalation

Remove person to fresh air and keep comfortable for breathing. Call a poison centre or physician if you feel unwell. If breathing is irregular or stopped, administer artificial respiration.

#### Ingestion

If accidentally swallowed rinse the mouth with plenty of water (only if the person is conscious) and obtain immediate medical attention. Do not induce vomiting.

#### 7.1 Precautions for safe handling

##### Safe handling

Wear appropriate personal protective equipment. Use only under a chemical fume hood. Keep away from heat/sparks/open flame/hot surfaces. Take measures to prevent the build-up of electrostatic charge. Ensure adequate exhaust ventilation, especially if dust, aerosol or fumes will be generated. Avoid contact with skin, eyes and clothing. For precautions see section 2.2.
